



## TERMS AND CONDITIONS OF THE PROMOTION

**“0 € registration fee, 0 € entry fee and 20% discount for one academic year for students willing to continue studies at the Warsaw School of Tourism and Hospitality Management or at Vistula University in the 2018/2019 academic year”**

1. The promotion is addressed to the full-time and part-time graduates of the **Warsaw School of Tourism and Hospitality Management** who have completed their studies in the 2018/2019 academic year and are willing to continue their studies (hereinafter referred to as “Studies”) in English or Polish, either full-time or part-time (including online studies) at the **Warsaw School of Tourism and Hospitality Management or at Vistula University** (hereinafter referred to as “School”) in the 2018/2019 academic year, and who have submitted a complete set of documents to the Recruitment Office between **23 January 2019 and 31 March 2019** and have been admitted as students of the School.
2. The Promotion entitles students to:
  - a 0 € registration fee
  - a 0 € entry fee
  - a 20% discount for one academic year

The tuition fees for studies are given in accordance with Order No. 01/12/2018 Chancellor of the **Warsaw School of Tourism and Hospitality Management** as of 10/12/2018. Tuition fees, including the 20% discount for one academic year of studies are given in the attachment no. 1.

3. To be entitled to the Promotion and thus the discounts stated in point 2 above, all the necessary documentation, including a signed copy of the **“0 € registration fee and 20% discount for one academic year 2018/2019 for continuing students”** Terms and Conditions contract have to be submitted to the Recruitment Office. On the day of signing the contract a yearly or a semester

payment has to be made (including the 20% discount given in point 2) specified in the Tuition Fees Order No. 01/12/2018 Chancellor of the **Warsaw School of Tourism and Hospitality Management** as of 10/12/2018. A confirmation of the payment must be included in the documentation submitted to the Recruitment Office.

4. The Promotion lasts from **23/01/2019** until **31/03/2019**.
5. The Promotion is addressed to students who do not hold a Polish citizenship.
6. The promotion cannot be combined with any other promotional offers of **Warsaw School of Tourism and Hospitality Management**.
7. If a student does not commence their studies, is removed from the student list in the first semester of the 2018/2019 academic year, resigns or does not make a payment as stated in point 2 of the Terms and Conditions, the entitlement to the Promotion will be cancelled and the School will be entitled to impose a registration fee and the payment for the whole duration of studies (in all kinds of payments) specified in Order No. 01/12/2018 Chancellor of the **Warsaw School of Tourism and Hospitality Management** as of 10/12/2018.
8. The Terms and Conditions are available on the website [www.vistula.edu.pl](http://www.vistula.edu.pl) and in the Recruitment Office.
9. If the student entitled to the Promotion resigns before the studies commence, resigns during the duration of the studies or is removed from the student list, the School will be entitled to withhold part of the fee, which might later be subject to a refund, to pay towards the costs which have not been paid for due to the Promotion.
